1. Garden

3. Library Meeting

1. Quick overview - There was a silent protest against some anti-trans athletes at the library that ended up being a rally. This led to library books being burned. Brittany reached out to the library asking for the event to be cancelled since it went against their policy. It's made folks who are LGBTQ+ and allies who work there feel unsafe and members of the community feel unsafe utilizing the library as a resource.
2. Would a meeting with the library to see how we can partner with them be helpful? General consensus is yes and in this meeting we want to be sure to talk about ways we can help them along with ways they can help us.
